Introduction

The impetus to co-produce this Equality, Diversity and Inclusion (EDI) Plan stems from a public workshop held in Belfast, February 2025, delivered by the NI Cancer Research Consumer Forum (NICRCF) and partners. The [report](#) of the event, which was part of a Macmillan funded project 'Close the Cancer Care Gap', illustrates the valuable insights gathered and indicates there is much to do! A NICRCF / NI Cancer Trials Network (NICTN) / Belfast Experimental Cancer Medicine Centre (ECMC) working-group has helped to produce this Plan in conjunction with partners, incorporating both public perspectives and best practice guidance specific to clinical research.

In 2024 the HSC R&D Division of the Public Health Agency and the University of Oxford Centre for Research Equity produced a partnership [Manifesto](#).

The Northern Ireland Cancer Trials Network and Belfast Experimental Cancer Medicine Centre have subscribed to the Northern Ireland Partnership Manifesto.

Advance the understanding of inclusive research practice and community engagement in Northern Ireland

Ensure health and social care research is inclusive and representative of Northern Ireland's population, delivering relevant and applicable outcomes

Build on the evidence base around the determinants of health inequalities, propose methods and research designs to improve outcomes for the population of Northern Ireland

Support inclusive engagement, involvement, and participation in research through a breadth of activities across Northern Ireland

Promote inclusive participation methods and accessible trials to ensure everyone has equal opportunity to take part and benefit from research

*Who are “underserved” communities?

In research ‘underserved communities’ can be wide-ranging. We use the National Institutes of Health Research (NIHR) guidance Improving inclusion of underserved groups in clinical research: Guidance from INCLUDE project | NIHR

‘The work of the NIHR-INCLUDE project shows that there is no single definition for an under-served group. Some key characteristics that are common to several under-served groups are:

- Lower inclusion in research than one would expect from population estimates
- High healthcare burden that is not matched by the volume of research designed for the group
- Important differences in how a group responds to or engages with healthcare interventions compared to other groups, with research neglecting to address these factors

The key idea here is that the definition of ‘under-served’ is highly context-specific; it will depend on the population, the condition under study, the question being asked by research teams, and the intervention being tested. No single, simple definition can encompass all under-served groups.’

EDI Objectives and Action Plan

EDI Objectives

1. Equity of access to the cancer trials portfolio across NI.
2. Increase access to cancer trials, including experimental cancer medicine clinical trials in NI.
3. Where appropriate and needed to support equity, facilitate trial pathways for patient participation in trials in Great Britain (GB) and Republic of Ireland (RoI).
4. NICTN / Belfast ECMC / NICRCF continue work with patients/carers and partner organisations in NI and across networks to identify the barriers and challenges to trial participation and research PPI, gaining greater understanding of barriers and 'under-served' groups, and share good practice.
5. NICTN and Belfast ECMC staff are trained in PPI, cultural competence and EDI, supporting PPI and EDI ethos in research delivery.
6. Increase awareness and understanding of cancer research and NICTN / Belfast ECMC / NICRCF/ PPI to support and promote participation and involvement in research / PPI opportunities.
7. Maintain and strengthen diverse and inclusive PPI in cancer research through inclusive NICRCF processes and membership, promoting equality of opportunity in cancer research PPI through outreach to local communities, building relationships with key stakeholders and 'underserved' groups.

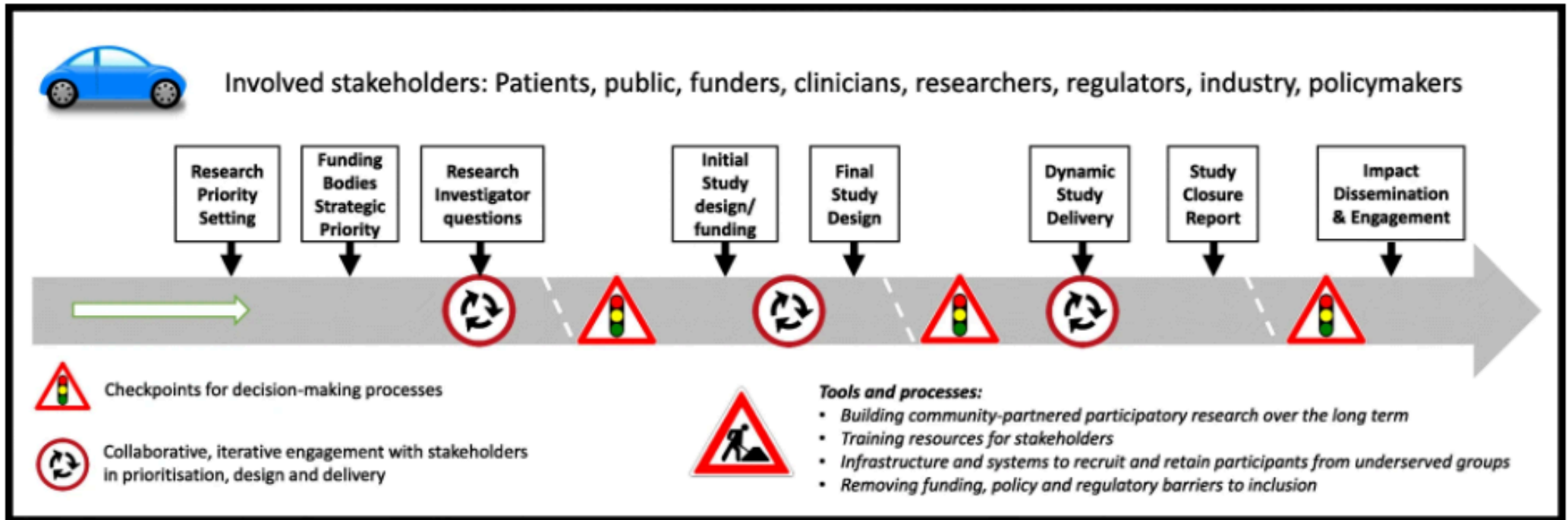
